UPDATES

Alexandros Savvaidis stated that with no additional funding TexNet will not be able to hire new staff. Due to the increase seismicity and no new hires, there is a delay in site visits, maintenance to stations and increase in the magnitude threshold we provide earthquake analysis.

PRESENTATIONS

TexNet operations update documented recent field visits to Eagle Ford, Delaware Basin and Midland Basin as well as the planned future work on a continuing basis. It was noted that the equipment originally deployed in DFW has now been refreshed with new equipment. The operational burden of increasing seismicity and increasing number of seismic stations has resulted in the reviewed bulletins being completed to M 2.5 at this point in time. Finally plans for additional station deployments in the Delaware and Midland Basins in response to seismicity was discussed.

Recent publications focusing on hypocentral depth determination and Vp/Vs ratio and a physical based model analysis of seismic events possibly associated SWD and HF were each reviewed.

An update was supplied on the expanding number of web tools being made available by TexNet.

Plans for the upcoming TexNet Biennial Report were presented and discussed. The plan calls for the review of the report during the second week of November. An update is planned for the October TexNet meeting.
