AGENDA ITEM I

AGENDA ITEM III

Douglas Dierking presents TexNet's current draft of their mission statement. Committee advises TexNet to identify as an independent body to classify as a separate entity from CISR (Center for Integrated Seismicity Research). Committee and TexNet begin framing the TexNet mission statement draft in open discussion where topics such as goals and values are discussed. TAC advises TexNet.

AGENDA ITEM IV

Through discussion TexNet and TAC identify the most important activities and gaps in the TexNet research. TexNet's goal is to produce and distribute data and science to create the understanding of earthquakes, but executing this to fulfill the needs of stakeholders should be identified for TexNet to properly accomplish its mission. TAC advises that critical needs may vary per stakeholder, and should be furthered discussed to create agreement of needs. TAC advice that TexNet needs to prioritize the idea of identifying potential risk factors of ground motion. TexNet agrees with TAC.

MISSION STATEMENT DRAFT

"TexNet is an independent scientific body that measures, analyzes, and distributes earthquake data and objective information to benefit the State of Texas". Committee agrees mission statement draft will need further adjustments to establish a statement where both TexNet and TAC agree is appropriate for the mission of TexNet. Final draft will be approved during the next meeting.

OBJECTIVES

- Produce and distribute accurate earthquake information on a timely basis
- Responsive to the critical information needs of the TRRC
- Responsive to the critical information needs of local communities
 - o What is the impact on the safety of residents and infrastructure
- Responsive to the need of the industry
 - o Decrease hypocentral uncertainty
 - o Understanding causality of seismicity
- Responsive to the need of the broad research community
- How much of risk does the seismic activity pose
- Communication with the public and media

APPROVAL OF AGENDA

The agenda was unanimously approved as distributed.

ADDITIONS TO AGENDA

Dana Jurick made a motion that identification of top three stakeholders of the TexNet program should be discussed. Committee agreed, facilitator then initiated discussion of TexNet and TACs priority stakeholders.

NEW BUSINESS

Seismic activity risks; causal contributors. Identify TexNet and CISR as independent entities. Infrastructure benefits from TexNet research data.
